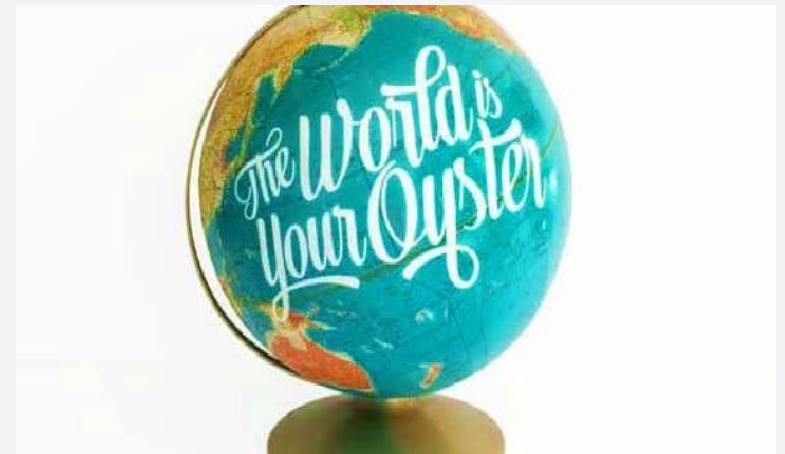

## A conversation with...

Prof. Hans Borgman, Professor of Information Systems and Digital Business, is the Academic Director for International Affairs, Faculty of Economics and Business, University of Amsterdam.

Prof. Borgman has been affiliated with the UvA's Amsterdam Business School since 2016. Before that he was professor of Business Administration at Leiden University. From 2011 to 2016 he was also professor at the ESC Rennes School of Business, a French Grande École where he was responsible for all doctorate degree programmes including two dual tracks in Beijing, China, and Rio de Janeiro, Brazil.

He has previously held professorial appointments at the European Business School in Wiesbaden, Germany, and the University of Michigan in Ann Arbor, USA.
